Introduction

This guidance document is for External Examiners appointed by University of Essex departments and aims to provide operational guidance on a number of online systems the University provides to support External Examiners in their role.

This guidance is aimed at External Examiners who have completed the appointment process and have been issued and returned their contract. External Examiners who have not yet submitted their online application to the role should refer to the [External Examiner New User Registration](#) guidance instead.

Directory of online resources

This section summarises the key systems that you may be required to access as an External Examiner for the University of Essex. Please note that systems used to share assessment materials can differ across University departments. The below systems are the most commonly utilised but, excepting the Report Portal which is universally used, you may not be asked to access all of these. If you are in doubt over which systems you need to access, please contact your appointing Department in the first instance.

- [FASER \(Feedback Assessment Submission Electronic Repository\)](#) is the University's online coursework submission, assessment and feedback service. To request guidance on how to use FASER, please e-mail your Departmental admin contact.
- [Moodle](#) is the University of Essex's Virtual Learning Environment (VLE); a web platform designed specifically to support the delivery of teaching and learning materials and activities. To request guidance on how to use Moodle, please e-mail your Departmental admin contact.
- [Box](#) is the University's official cloud storage and collaboration platform for staff and students. To request guidance on how to use Box, please e-mail your Departmental admin contact or refer to the guidance materials within your Box folder.
- The [External Examiner Report Portal](#) is an online submission system for External Examiner reports. All External Examiners are required to submit reports through the online Portal no later than four weeks after the date of their final Board of Examiners. To request guidance on how to use the Report Portal, please email Quality and Academic Development team on external.examiners@essex.ac.uk, or refer to the [systems guidance](#).

Your University of Essex account

Once a new External Examiner has returned their signed contract and payroll form to external.examiners@essex.ac.uk they will be added to the University of Essex HR systems as a University employee and an institutional log-in will be generated.

Your University of Essex log-in will be used for accessing password-secured online systems and will be needed for accessing Board of Examiners meetings held via video call. As part of the activation process, you will set up an automatic forwarding address so any messages directed to your Essex email will be automatically redirected to a registered personal email address. You will not need to check an additional inbox for University of Essex matters.

Activating your account

A member of the Quality and Academic Development team will contact you with instructions on activating your University of Essex account once it has been generated. The University will require your signed contract to have been returned before your account can be generated.

You will be informed of your Personal Record Identifier (PRID). This is a set of numbers and letters that the University uses to uniquely identify all students and staff e.g., SMITH12345. You need your PRID to access some University services so please keep a record of this, or contact external.examiners@essex.ac.uk to be reminded of it.

- Access the following link to [get your Essex IT account details](#). Please input your PRID as it appears in this email and click **Submit**.
- You will then be asked to **provide an external email address and passphrase**. Your external email address and passphrase is separate to your Essex email address and password and can be used to reset your Essex password if you forget it. Emails sent to your Essex email address will automatically be forwarded to your external email address.
- On the following page, please input your personal details exactly as previously supplied to us. All fields on this page are case-sensitive, so this stage will not work if the personal information you supply does not match that which we have on record.

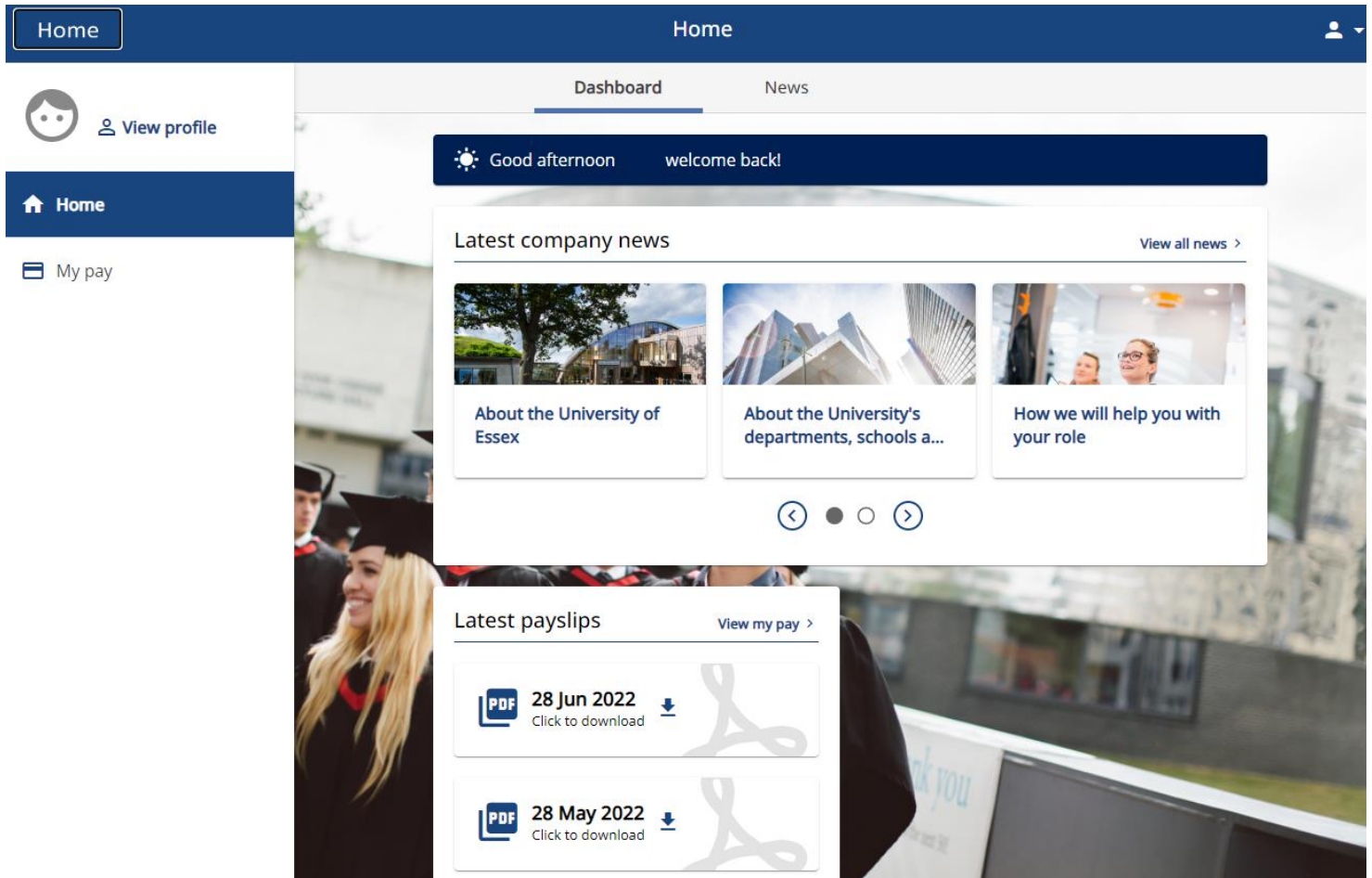
If you have forgotten your University of Essex password, you can [request a one-time password be sent to your registered mobile phone or external email address](#).

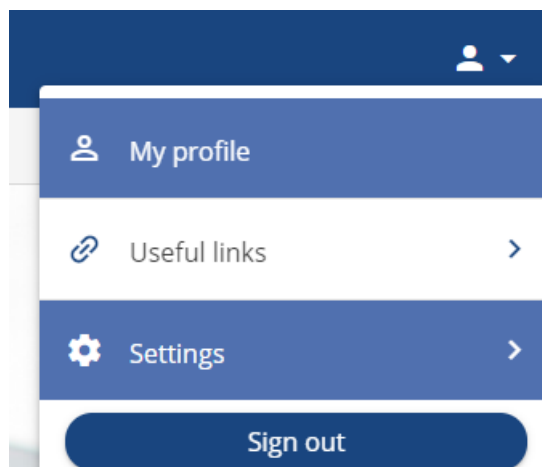

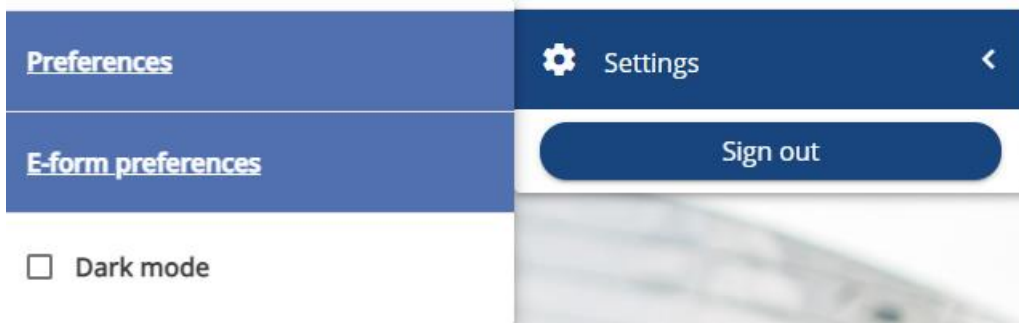
Payslips and other financial information

The above screenshot illustrates the homepage of HR Organiser. Your payslips can be downloaded from the **Latest payslips** section at the bottom of the screen, or else click **View my pay** to access older payslips and any P60s. External Examiners responsible for postgraduate taught provision should note that tax is not deducted at source for their fees, and their P60s will appear as blank.

If you would like to set up your account so that payslips are automatically forwarded to your external email address and you do not need to access HR Organiser each year to individually download each payslip, click on the icon in the top right corner of the screen and select **Settings**.



Select **E-form preferences**.



On the **E-form preferences screen**, ensure **Email payslip** is checked and enter an email address for payslips to be sent to, and your password for accessing them. Click **Save** to apply these preferences.

Claiming Expenses

Claims for expenses should be submitted to external.examiners@essex.ac.uk on the [External Examiner Expenses Claim Form](#). Claims should be submitted in line with [approved rates](#) published online and outlined on the first page of the claim form.

Submission of your annual report

At the end of each academic year of appointment, External Examiners are required to submit a report detailing their views on particular elements of the courses and/or modules which they oversaw. These formal written reports form a key element of the process for maintaining academic standards at the University and provide essential feedback for our departmental teams.

The [External Examiner Report Portal](#) is an online system which will enable you to input your annual report and to view the formal response that your appointing Department has offered to your feedback. It will also provide a means for you to check the details of your appointment online, including your contract start and end dates, and the schedule of courses and/or modules that you will be responsible for.

Adding your report

When you log into the [Report Portal](#), you will see the following screen:

You will then be able to select **Add Report** and you will need to complete each area on the screen, choosing from a drop-down list.

If you are responsible for courses and modules in more than one **Department**, please select the appropriate department for your report. If you are submitting two reports for the same department, please remember to repeat this process twice, selecting the same department for both reports. **Please remember that reports must be submitted one per provision (UG/PGT) and not one per course/module.**

The **Report type** refers to the level of provision you are responsible for (UG – undergraduate, or PGT – postgraduate). Please note that if you are responsible for both undergraduate and postgraduate provision, you will need to input two separate reports.

If you are a PGT External Examiner and wish to submit a report subsequent to an interim exam board, please select **Interim Report** as your report type.

Choose the relevant action from the drop-down list and press the **Next** button.

To complete the report, choose the **Update Report** option from the drop-down menu at the bottom of the screen. You will then be able to access your report to continue work on it.

IMPORTANT NOTE: Do not open the Report Portal in multiple tabs in your browser. When drafting your report, please do not try to open your previous year's report in a separate tab as there is a risk that this can cause system errors when saving your current year's report. If you need to refer to your previous year's report, please ensure that this is accessed/extracted before you begin drafting a new report.

Submitting your report

Once you have completed your report, please click **Submit completed report**:

Click save if you would like to save and return to finish your report at a later date.

Click submit if your report is complete and you wish to submit it for review.

Save and exit

You will be prompted to confirm that you have not referred to staff or students by name and once you have checked the box, you will be able to select **Submit completed report**. This will trigger an e-mail to the Quality and Academic Development team. Please note that once submitted, unless there is a query with your report, you will not be able to make any additional changes to it.

Should you NOT wish to confirm this at this stage, pressing the **Exit** button will save the report.

If amendments to your report are required, you will receive an email requesting that you make the appropriate amendment. An example of this could be if a staff or student name/number requires anonymization, or if your department would like more detailed feedback offered to a certain section of the report. Until the amendments are made and the report resubmitted, the Report Status will read **Pending**.

You will be able to view your submitted report(s) from this screen by choosing **View Report** from the drop-down menu options.

The month before the end of your appointment, the Quality and Academic Development Team will send you an email informing you that your term of appointment will be shortly coming to an end.

If you need to make changes to your contract, please discuss this further directly with the Department who will advise accordingly and submit a contract change request to QUAD if required. Changes to contracts require approval and this process is managed through the portal, updating all parties throughout.
