

# Essex Undergraduate Global Partner Scholarships 2023-24

If you're an international student studying at one of our global channel partners, you could be eligible for a scholarship worth up to £3,000, which you'll receive as a tuition fee discount distributed across your years of study.

## Terms and conditions

### Eligibility

- These scholarships are restricted to students who are overseas fee payers and are entirely self-funded\*.
- Only those applicants put forward by one of our Global Channel Partners listed above will be considered for this award (excluding applicants on the UKT Law programmes with specific partner institutions for which we have a separate scholarship – please see Essex Law Global Partners Scholarship T&Cs for eligibility requirements).
- Applicants must meet our standard conditional offer (not including any flexible offer level, see exceptions to this below).
- UCAS applicants must actively make Essex their firm choice by 14 July 2023. Applicants that become firm with Essex through rejection by their original firm choice selection elsewhere are not eligible. Direct Applicants must accept their offer by 14 July 2023.
- GDUFS students are only eligible for the award if they achieve 85% or above in link agreement programme/s.
- Shanghai University students are only eligible for the award if achieve 75% or above in link agreement programme/s.
- CSCSE students are only eligible for the award with A in one graded component for 3+1 SQA entry in link agreement programme/s.
- Students must be starting their first year of undergraduate study at Essex in 2023-24.
- Only one scholarship award can be made per student and the award cannot be held in conjunction with any other University of Essex scholarships.
- Successful applicants should be available for promotional activities

\*Students receiving a repayable loan to fund their studies will be considered as self-funded.

### Students who are not eligible

The following students are NOT eligible for this scholarship regardless of meeting the above criteria:

- Students undertaking courses at East 15 Acting School.

- Current students are not eligible for this award.
- Students who are classified as a Home fee paying student.
- Students who are fully or partly sponsored.
- Students undertaking a degree that is normally delivered wholly online
- Students placed through any Clearing intake are not eligible for this award.
- Students studying the EWIE joint educational programme
- This scholarship award does not apply to deferred entry. Where a scholarship has been awarded to a student who subsequently defers entry to the following academic year, the award will be withdrawn and the applicant will be considered again in line with the terms and conditions that apply in the new proposed year of entry.

## How to apply

If you meet all the eligibility criteria, you will automatically be considered for this award. You don't need to complete an application form. The University will assess your eligibility based on your country of domicile and fee status that you submit on your application for your place at Essex.

## Payment arrangements

- These scholarships will only be made available as a reduction on the tuition fee that is payable on registration at the University. Payment cannot be offset against a tuition fee deposit if one is required.
- If you intermit from your course, you may, at the discretion of the University, be entitled to a pro-rata payment of the remainder of your award on your return to study. Please contact the [Funding Team](#) for further information.

## Resolution of disputes

Acceptance of this award constitutes acceptance of these terms and conditions. Registered students should contact the [Funding Team](#) in the first instance for guidance regarding this award. In cases not covered by the above terms and conditions, or where a student claims exceptional circumstances, or disputes a decision not to make payments due under an award, final appeals on decisions regarding eligibility must be made via the [Student Complaints process](#). The Academic Registrar or their nominee will review the case and his/her decision will be final.
