

INTI Malaysia Law Transfer Programme Scholarship 2019-20

If you're an international student studying at one of our global channel partners, you could be eligible for a scholarship worth up to £3,500, which you'll receive as a tuition fee discount distributed across your years of study.

Terms and conditions

Eligibility

- These scholarships are restricted to applicants who are classified as international students for fees purposes
- Applicants must be entirely self-funded. These awards are not available to students who are fully or partly sponsored.
- Applicants must be studying on the Law transfer programme at INTI, Malaysia specified in the link/partnership agreement between the University and INTI.
- Applicants must meet our standard conditional offer (60% for 2+1 route and 50% for 1+2 route).
- Applicants must make Essex their firm choice on UCAS by 18 July 2019.
- Applicants must be starting their undergraduate study at Essex in 2019-20.
- Current students are not eligible for this award.
- Applicants placed through the UCAS clearing process are not eligible for this award.
- Only one scholarship award can be made per student and the award cannot normally be held in conjunction with other University of Essex awards.
- The scholarship amounts and eligibility per year is set out in these terms and conditions.
- These scholarship awards do not apply to deferred entry. Where a scholarship has been awarded to a student who subsequently defers entry to the following academic year, the award will be withdrawn and the applicant will be considered again in line with the terms and conditions that apply in the new proposed year of entry.

Students who are not eligible

You are not eligible for the award, even if you meet the criteria above, if you fall into any of the following categories:

- your course is at East 15 Acting School

How to apply

If you meet all the eligibility criteria you will automatically be considered for this award. You don't need to complete an application form. The University will assess your eligibility based on the academic transcripts and certificates that you submit with your application for your place at Essex. No alternative supporting evidence will be accepted.

Notification

Successful applicants will be informed of any award to be offered by approximately the beginning of September.

Payment arrangements

- These scholarship awards will only be made available as a reduction on the tuition fee that is payable on registration at the University.
- If you intermit from your course, you may, with the agreement of your department and at the discretion of the Director of Marketing and Student Recruitment, be entitled to a pro-rata payment of the remainder of your award on your return to study. Please contact the Funding Team for further information.

Resolution of disputes

Acceptance of this award constitutes acceptance of these terms and conditions. Registered students should contact the Student Funding Team in the first instance for guidance regarding this award. In cases not covered by the above terms and conditions, or where a student claims exceptional circumstances, or disputes a decision not to make payments due under an award, final appeals on decisions regarding eligibility must be made via the Student Complaints process. The Academic Registrar or their nominee will review the case and their decision will be final.
